#### Licensure of Dietitians in West Virginia

The WVAND Public Policy Committee has been working hard to keep hard won licensure from being removed. WVBOLD and WVAND partnered to meet with a joint interim session of the WV HOD and Senate Government Organization Committee on September 13. Efforts focused on ensuring that the PERD assessment does not result in

removal of licensure. The Public Policy Committee hosted a Virtual Townhall Meeting on the topic of licensure on September 20. Eighteen (18) WVAND members on and ten (10) non-members participated in the webinar. Registered dietitian nutritionists practicing in West Virginia are "health care practitioners" under West Virginia law and by virtue of being included in that term, RDNs are immediately integrated into the West Virginia health care regulatory and payment structure in hundreds of ways. Licensure is a prerequisite to being included in the definition of "health care practitioner" in West Virginia, so without the ability to get licensed, West Virginia RDNs would no longer be considered a "health care practitioner" for purposes of providing telehealth or obtaining health insurance reimbursement.

#### **WVAND Virtual Townhall and Fall HOD Meeting**

Cathy Shaw, WVAND Delegate to the Academy, led a Virtual Townhall on September 7 to discuss proposed bylaws changes. Participants had a robust conversation about the future of the Academy and the importance of our delegate. The Academy of Nutrition and Dietetics House of Delegates (HOD) Meeting occurred September 17-18. As a result of voting, the HOD retains the authority to vote on future bylaws amendments. **Learn More**
